

## DEFINITIONS AND LICENSE ENTITLEMENT INFORMATION

**B2Bi:** The below terms shall apply to this Axway product provided under the following deployment and pricing models:

**Deployment Model:** Perpetual On-Premise

**Pricing Model:** B2Bi Partners/WebTrader Users

**1. DEFINITIONS.** As used herein, the following capitalized terms shall have the following meanings:

- **“Cluster”** means one (1) or more Instance(s) behaving as a single system running on one or more physical or virtual machine(s).
- **“Environment”** means the combination of one or more systems and software that is directly connected with each to form and provide a specific service.
  - A **“Disaster Recovery (DR) Environment”** is an inactive Environment which starts executing when the Production Environment fails.
  - A **“Non-Production Environment”** is an Environment used for processing data for other purposes than Production processing. Examples of these are: Development, Test, UAT, QA, Integration Testing.
  - A **“Production Environment”** is an Environment used for data processing to support the actual business processes of Customer, Production Environments are typically connected to Production Instances of other software and/or external business partners, for business data exchange.
- **“Instance”** means software running in one (1) computer system as a single occurrence in RAM (Random Access Memory).
- **“Named User”** means a named employee of Customer authorized to access the applicable Axway software products
- **“Node”** means a single computer system (physical or virtual) executing a single Instance of a Product.
- **“Partner”** means software or a system inside or outside a Customer environment that interacts with the Axway software (via one or more communication protocols, a shared folder, a connector on one or more networks and one or more adapters), whether as a sender or as a recipient, for the purpose of exchanging data. Partners are represented in B2Bi as object type Partner. For clarification and the avoidance of doubt: (a) third parties acting as intermediaries for data exchanges are counted as Partners if they are configured as object of type Partner, and (b) If the exact same Partner is configured on multiple independent Clusters (identified by the same default “RoutingID”), that Partner will be counted as one (1) Partner.
- **“Production”** means use to support the actual business processes of Customer
- **“Usage Metrics”** means the quantitative limitations and units of measure, along with any other grants or restrictions on use, set forth in this Order Form
- **“WebTrader User”** means a Named User that interacts with the WebTrader User interface for the purpose of data exchange. For clarification and the avoidance of doubt, WebTrader Users are not counted as Partners.

**2. ENTITLEMENT INFORMATION AND RESTRICTIONS.** Customer entitlements are in all cases limited to the applicable Usage Metrics specified in the Product Schedule and as may be otherwise specified herein.

**a. Included Entitlements.** Unless otherwise specified in this Order Form, Customer’s license entitlements shall include the following entitlements:

- i. Partners/WebUsers.** The total number of Partners and WebTrader Users across all Production Instances combined may not exceed the total number of Partners and WebTrader Users specified. For clarification and the avoidance of doubt, WebTrader Users are not counted as Partners.

- ii. **Protocols/Formats.** Customer's entitlements are limited to the protocols and formats supported by Axway B2Bi. Notwithstanding the foregoing, when "Communication-only mode" is selected, the protocols and formats are limited as set forth below. For details about supported protocols and formats, see product documentation for B2Bi available at <https://docs.axway.com/>.
  - iii. **Sentinel.** Customer is entitled to use of Sentinel, including Sentinel Web Dashboard, but solely for the purposes of monitoring transactions flowing through B2Bi. The license to Sentinel includes an unlimited number of users and Instances of Sentinel.
  - iv. **Secure Relay**
  - v. **Unlimited Production, Non-Production, and Disaster Recovery Environments.** Disaster Recovery Environments may only be used in the event the Production Environment fails. In the event the Disaster Recovery Environment is used for Production, such use will be considered Production use.
- b. **Optional/Selectable Entitlements.** If purchased by Customer as set forth in the Product Schedule above, Customer's entitlements shall include the following:
- i. **Communication-only mode.** When selected, Customer is entitled to use all communication protocols supported by the B2Bi Trading Engine. However, use of any messaging formats for transformation or any other functionality of the B2Bi Integration Engine are not included in the license. See product documentation for B2Bi on <https://docs.axway.com/> for details about B2Bi Trading Engine and Integration Engine.
  - ii. **Clustering - Active/Active.** Customer is entitled to run any number of multi-Node B2Bi Active/Active Clusters. Each B2Bi Active/Active Cluster is technically supported up to the number of Nodes indicated in the documentation of the actual product version (currently up to four (4) active Nodes).
  - iii. **Multi-Cluster.** Entitles Customer to setup B2Bi Environments using the B2Bi "Multi-Cluster" capability. A B2Bi Multi-Cluster can consist of single Node B2Bi Instances. A B2Bi Multi-Cluster can contain "Active/Active" Clusters only if the Active/Active Clustering has been entitled.
  - iv. **FIPS.** Entitles Customer to use B2Bi in FIPS enabled mode.
- c. **Other Restrictions**
- i. If Customer makes a future purchase of additional Cores and has already purchased Active/Active Clustering or Multi-Cluster, Customer will be charged a clustering uplift charge for the additional Cores purchased.
  - ii. If Customer adds Active/Active Clustering or Multi-Cluster to Cores previously purchased without previously purchasing these options, Customer will be charged a clustering uplift for the total number of Cores purchased.
